He further requested for the permission to hold an initiation programme in a temple situated outside the jail premises, officials aware of the matter said.

Superintendent of Almora jail Jayant Pangtey on Monday said: "We have received a handwritten letter from Prakash Pandey in which he has mentioned that he wants to repent for his past crimes and wants to become a monk now. He has requested permission to hold an initiation programme in a temple outside of the jail building."

According to police, around 45-year-old PP hails from Chhota area of Ramnagar in Nainital district. He got into the crime world and became an aide of another notorious don Chhota Rajan. Police have registered several cases on charges of murders, extortion, kidnapping and
